Schadenersatz- und Aufwendungsersatzansprüche (nachstehend zusammenfassend „Schadenersatzansprüche“) des Kunden gegen die Indi.An GmbH, gleich aus welchem Rechtsgrund, sind ausgeschlossen, es sei denn, sie beruhen auf den Bestimmungen des Produkthaftungsgesetzes, einer vorsätzlichen oder grob fahrlässigen Verletzung vertraglicher oder gesetzlicher Pflichten durch die Indi.An GmbH, Gesundheits- und Körperschäden des Kunden infolge einer von der Indi.An GmbH zu vertretenden Pflichtverletzung, der Übernahme einer Garantie für das Vorhandensein einer Eigenschaft oder der Verletzung wesentlicher Vertragspflichten (Kardinalpflichten) durch die Indi.An GmbH.
